Week booking Discount

When registering for a week long camp at Introsport, the participant will be entitled to a discount of £10 a day rather than £15 daily charge.

Payments

To reserve a space, the full fee of the booking must be paid.

Refund / Cancellation Policy

Refunds will be issued for early withdrawal due to illness, absences, behavioral dismissals, power failures, unforeseeable events not within the control of Introsport. If students do not attend camp without sufficient evidence, no refund will be issued.

Balance payments, less deposit, are refundable up until 5 days prior to the start of the confirmed camp week. No refunds will be issued for cancellations within 4 days of the start of confirmed camp week. All cancellations must be submitted in writing and submitted to the companies email address or spoken over the phone, within 5 days of the camp.

OTHER INFORMATION

Upon registration, you will need to submit to iD Tech Camps information regarding all of the following information about your children, including: allergies, illnesses, medications, dietary restrictions, immunizations, emergency contact information, gender and date of birth. We ask for the Primary Contact Person in case of emergency (in addition to a Secondary Contact Person) and information concerning these parties—such as name of contacts, phone numbers, email, and address. This information is to be filled out by Parent/Guardian. Please provide updated and complete information. Please read through it carefully. You will be asked to take as much time as you need. If you have any questions, please contact us via email or telephone. The information we collect is CONFIDENTIAL and is used to aid the Camp Tutor in assessing crucial information regarding your child.

You will also be asked to identify any medical condition or history that would require special attention. You will need to certify that the named student is physically able to participate in all camp activities, including Sports and Games.

ALLERGIES/DRUG REACTIONS and Management of Reactions. For instance, PEANUTS. You will be asked to chronicle any known allergies. You will be asked if student is bringing an EPIPEN to camp. If so, you will be asked to verify the prescription.

Additionally, you will be asked to sign off on all known illnesses or conditions which the student has or has had: Illness, Allergies, Drug Reactions. You will be asked to fill out a list of prescribed medications your son/daughter/ward MUST take while attending camp. You acknowledge that the medicine and/or vitamins are to be in the possession of the Camp Director, delivered to the Camp Director in original containers that identify, in English, the prescribing physician (if a prescription drug), the name of the medication, the dosage, and the frequency of administration, and will be dispensed as instructed by you. Exception: INHALERS. All medication brought to camp MUST match what is listed in the student's Health History form, located in your Camp Account. Any discrepancies may result in long delays at check-in and may require the cancellation of the camp week, without a refund. Our camp staff needs your full cooperation. Thank you for understanding. You also understand that no one at Introsport is authorized to give any student any over-the-counter medications without your written permission. In most cases, our camp personnel are not professional nurses or doctors, and have not been trained in medicine. Our camp personnel have, however, been trained in First Aid procedures.

YOU HEREBY WAIVE AND RELEASE ID TECH CAMPS, ITS OWNERS, AGENTS, PARTNERS, FACILITY PROVIDERS, AND EMPLOYEES FROM LIABILITY FOR ANY INJURY OR ILLNESS INCURRED WHILE AT CAMP. YOU UNDERSTAND THAT THERE IS RISK OF INJURY TO THE NAMED STUDENT AS A RESULT OF CAMP ACTIVITIES, AND KNOWINGLY AND VOLUNTARILY ASSUME ALL RISK OF SUCH INJURY. By submitting the information, it certifies that you, the Parent/Guardian, agree to the terms stated above, and have taken the time to ensure that ALL information in the HEALTH AUTHORIZATION AND RELEASE FROM LIABILITY FORM IS UP-TO-DATE AND ACCURATE TO THE BEST OF YOUR KNOWLEDGE.

Information we ask for is: Name of Student's School he/she attended in the past school year.

Please describe student's strengths and challenges in classroom and social settings. Please tell us about what you would like the student to take away from the camp experience. Describe any learning, physical, or attention challenges you would want our Introsport Director to be aware of. In order for us to better support your student, are there any situations such as the loss of a family member, pet, or recent divorce that our staff should be aware of? If so, please describe.

You are aware that your son/daughter/ward may be participating in activities such as sports, football, basketball and other recreational activities, and that such activities contain inherent risks of injuries. You assume all risks and understand that Introsport it's owners, agents, partners, facility providers, and employees will not be held liable for damages or injuries associated with recreational activities, including any and all claims based on negligence. You understand that you must report any and all injuries immediately to the Introsport Director and Regional Manager. Should any part of this contract be found invalid or not enforceable by law, then the remaining portion shall continue to be valid and in force.

You agree that as the parent/guardian of the named Student, you certify that your son/daughter/ward has your permission to attend and participate in the Introsports Camps program. The camp has the right to dismiss any individuals if their actions or attitudes are deemed detrimental, as set forth below in the Introsport Code of Conduct, to the general atmosphere of the camp and that there shall be no refunds issued for such dismissal.

You authorize the camp staff to attend to health problems or injuries your son/daughter/ward may incur while attending camp.
